"Relevant period" means the period of 12 months ending with the day on which you give notification for the purposes of section 30(1) (disclosure on taking office) or section 31 (7) (where the interest is not one already on the register or subject to a pending notification to the Monitoring Officer).

"Securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

Failure to register disclosable pecuniary interests as required by the legislation is a criminal offence under the Localism Act 2011.
